

ACCIDENT WAIVER AND RELEASE OF LIABILITY FORM (MINOR CHILD)

I HEREBY CERTIFY THAT I AM THE ADULT PARENT OR GUARDIAN OF _____, A MINOR CHILD UNDER THE AGE OF EIGHTEEN (18) YEARS, AND I ASSUME ALL OF THE RISKS OF HIM/HER PARTICIPATING IN ANY/ALL ACTIVITIES ASSOCIATED WITH DRAGON FIT TAMPA, LLC, including by way of example and not limitation, any risks that may arise from negligence or carelessness on the part of the persons or entities being released, from dangerous or defective equipment or property owned, maintained, or controlled by them, or because of their possible liability without fault.

I certify that the named minor child named above is physically fit, has sufficiently prepared or trained for participation in this activity, and have not been advised to not participate by a qualified medical professional. I certify that there are no health-related reasons or problems which preclude the minor child from participation in this activity.

I acknowledge that this Accident Waiver and Release of Liability Form will be used by the event holders, sponsors, and organizers of the activity (classes, Open Gym, Competitions or use of the gym) in which the minor child named above may participate, and that it will govern the minor child's actions and responsibilities at said activity.

(B) INDEMNIFY, HOLD HARMLESS, AND PROMISE NOT TO SUE the entities or persons mentioned in this paragraph from any and all liabilities or claims made as a result of the minor child's participation in this activity, whether caused by the negligence of release or otherwise and regardless of fault.

I acknowledge that Dragon Fit Tampa, LLC (Dragon Fit) and their directors, officers, volunteers, representatives, and agents are **NOT** responsible for the errors, omissions, acts, or failures to act of any party or entity conducting a specific activity on their behalf.

I acknowledge that this activity may involve a test of a person's physical and mental limits and carries with it the potential for death, serious injury, and property loss. The risks include, but are not limited to, those caused by terrain, facilities, temperature, weather, condition of participants, equipment, vehicular traffic, lack of hydration, and actions of other people including, but not limited to, participants, volunteers, monitors, and/or producers of the activity. These risks are not only inherent to participants, but are also present for volunteers.

I hereby consent on behalf of the minor child named above to receive medical treatment which may be deemed advisable in the event of injury, accident, and/or illness during this activity.

I understand while participating in this activity, the minor child may be photographed. I agree to allow the minor child's photo, video, or film likeness to be used for any legitimate purpose by the activity holders, producers, sponsors, organizers, and assigns. The Accident Waiver and Release of Liability Form shall be construed broadly to provide a release and waiver to the maximum extent permissible under applicable law.
